What is InSPPIRE?

InSPPIRE is a project that aims to facilitate learning on refugee education in high-income settings and inform policy and practice. It seeks to do this by identifying promising practice case studies in a range of high-income countries (HICs), synthesising and amplifying learnings from them.

InSPPIRE is led by [Refugee Education UK](#) (REUK), a UK-based charity working towards a world where all refugee children and young people can access education, thrive in education, and use that education to create a hopeful, brighter future. It is carried out in partnership with a steering group of refugee education academics and practitioners from REACH at the Harvard Graduate School of Education, Qatar Foundation International, Sirius, UNHCR and the University of Nottingham.
